IMPACT OF ASTHMA & ALLERGIES

- Asthma & Allergies affect ~76 million Americans (~50 M for allergies)
- 15 Million affected by Food Allergies
- Asthma accounts for 1/4 of all U.S. ED visits (2 million)
- Food Allergy reactions = 200K ED visits
- Asthma accounts for more than 14 million outpatient visits and 439,000 hospitalizations yearly

IMPACT OF ASTHMA




- The prevalence of asthma has been increasing since the early 1980s across all age, sex and racial groups
- Asthma is the most common chronic condition among children
- Annual cost of asthma is estimated to be nearly \$56 billion in direct & indirect costs

IMPACT OF ASTHMA

- Asthma is consistently one of the top five <u>most</u> <u>costly</u> health conditions
- Asthma control is strongly affected by many factors outside of the doctor's office, including patient behavior and environmental factors such as smoking, outdoor & indoor air pollution, and household pests

IMPACT OF ASTHMA

• Ethnic differences in asthma prevalence, morbidity and mortality are highly correlated with poverty, urban air quality, indoor allergens, and lack of patient education and inadequate medical care



IMPACT OF ASTHMA – DISPARITIES

- Greatest rise in asthma was among African American children: 1 in 6 African American children have asthma
- African Americans are three times more likely to be hospitalized from asthma
- African Americans are three times more likely to die from asthma
- African American women have the highest mortality rate of all groups due to asthma

IMPACT OF ASTHMA – DISPARITIES

- 16% of African American children have asthma compared to 8.2% of white children
- For African Americans, the rate of emergency department visits is 330% higher and the rate of hospitalizations is 220% higher compared to whites

IMPACT OF ASTHMA – DISPARITIES

- Approximately 3 million Hispanics in the US have asthma and Puerto Ricans are disproportionately impacted
- Current asthma prevalence is 80% higher for Puerto Ricans than whites
- Puerto Ricans have the highest rate of asthma attacks

IMPACT OF ASTHMA - MICHIGAN

- \circ Nearly 1 million \sim 25% are children
- Rate is 25% higher than national average
- Only 40.4% of children & 33.8% of adults met the national treatment guideline recommendation of at least 2 routine asthma care visits during 12 months
- Only 30% of children with persistent asthma are filling prescriptions for inhaled corticosteroids; the preferred, first-line medication

IMPACT OF ASTHMA - MICHIGAN



- From 2004 through 2006, there were 393 asthma deaths in Michigan
- Deaths for residents of Wayne County (197deaths) during 2002-2006 account for 30% of all deaths for Michigan residents
- Michigan counties with highest rates of asthma death were Bay, Genesee, Ingham, Oakland, Macomb, Monroe, Muskegon, Saginaw, Washtenaw & Wayne Counties

IMPACT OF ASTHMA - MICHIGAN

- Cost estimates based on national figures suggest that Michigan spends over \$225 million in direct medical costs and an additional \$170 million on indirect costs
- Estimated costs of asthma hospitalizations in Michigan \$11,671
- The average cost for blacks is higher than that for whites (\$11,922 versus \$10,549)

IMPACT OF ASTHMA - DETROIT

- Ranks 4th in the Nation as one of "The Most Challenging Places to Live with Asthma." Asthma and Allergy
 Foundation of America (AAFA) 2015

THEREFORE:

•Asthma is a condition that requires coordinated and collaborative efforts of doctors, nurses, pharmacists, patients, health systems & coverage providers **AND** community organizations to ensure better outcomes for patients as well as improving community health

A FEW POSSIBILITIES



HOME VISITS

- According to the CDC, home-based multitrigger, multi-component, interventions with an environmental focus are effective in improving overall quality of life and productivity in children with asthma
- And are a good value for the money invested
- In MI: Managing Asthma Through Case Management (MATCH) program
 - + outcomes

HOME VISITS DETROIT - EXAMPLE

- Over 40 home visits in 2012-2013 in Detroit
- Biggest barrier is getting "in"
- Once there interest and behavioral changes happen
- Phone survey revealed majority of participants in good control 3-6 months post program, only one family had issues needing emergency care
- Next barrier is increasing qualified educators & Org's to provide visits

GREEN & HEALTHY HOMES INITIATIVE

THE BOTTOM LINE

- Proper asthma management has the potential to save at least 25% of total asthma costs—or close to \$5 billion nationwide annually
- Asthma interventions can <u>save up to \$36</u> in health care costs and work days lost <u>for every \$1 spent</u>
- Targeted Asthma programs improve quality of life, save lives, and enrich community wellness
